NOTICE: Inspections scheduled by 6:30am on a working day will be performed the same working day.

Note: Write down your confirmation number to verify the inspection request has been processed.

For cancellations after 7:00am, call (970) 244-1631

NOTICE NO WORK SHALL BE COVERED OR CONCEALED UNTIL INSPECTED AND APPROVALS RECORDED ON THIS CARD.

ANY SYSTEM REVISIONS MADE AFTER PLAN REVIEW BY THE DEPARTMENT MUST BE SUBMITTED IN WRITING TO THE DEPARTMENT AND APPROVED PRIOR TO IMPLEMENTATION.

ALL FAILED INSPECTIONS- CORRECTIONS MUST BE MADE, AN INSPECTION MUST BE RE-CALLED AND THE CORRECTIONS MUST BE APPROVED PRIOR TO COVERING OR CONCEALING.

SITE REQUIREMENTS

In order to request an inspection the following must be located on site:

Address must be posted at road

The Inspection Card must be present

INSPECTION INFORMATION

Inspections will be performed by Mesa County Building Department staff Monday through Friday from 8:30am to 3:30pm

All inspections must be requested by calling the inspection line (970) 256-1564

Inspections can be called in 24 hours a day

Inspections called in after 6:30am will be schedule for the next working day

Inspections may be schedule for 1 or 2 days in advance; Most inspections will be performed 5 days per week

To cancel inspection after 6:30am call (970) 244-1631

***Note: For pressurized systems only- inspections must be called in to both the IVR (970) 256-1564 leave a message for the inspector indicating what time the engineer will be onsite and a good contact number.**
