

## ELECTRONIC & HAZARDOUS WASTE DISPOSAL

The Mesa County Landfill does not accept electronic waste (e-waste) or other hazardous wastes. This means these items cannot be thrown away in your household trash or left out for the Neighborhood Clean-up.

### E-WASTE

The majority of electronic devices contain some amount of lead, mercury and cadmium- all of which can be potentially hazardous to the environment when not properly managed. For a list of these devices, please see the section on "Items We Will Not Pick-Up".

## WHAT IS THE NEIGHBORHOOD CLEAN-UP?

The Neighborhood Clean-Up was first piloted in 2019 in response to community members wanting to transform their neighborhoods. Since its inception, this collaborative effort has expanded to more neighborhoods promoting solid waste disposal through engagement and awareness of community members who are also actively involved in the clean-up. The result is a safer, healthier Mesa County that promotes a sense of pride and community.

## WHERE TO PLACE YOUR PILE

Place your items in **ONE** pile, **in the street**, up against the gutter, in front of YOUR house.

If your house is in an area with no on-street parking, you will receive a separate notification on where to place your items.

## ITEMS WE WILL NOT PICK UP

- Tires
- Asphalt/ Concrete Rubble
- Engines/ Fuel Tanks
- Gas/ Air Cylinders
- Items longer than 6 ft. in length
- Microwaves
- Lawn Mowers
- Refrigerators/ Freezers
- Air Conditioners

## HAZARDOUS MATERIALS:

- Liquids of any kind
- Antifreeze/ Oil
- Grease
- Gasoline/ Diesel
- Paint/ Stain
- Batteries

## E-WASTE:

- Cell phones/ PDA's
- Televisions/ Monitors
- VCR/ DVD Players
- Printers/ Copiers
- Scanners/ Fax Machines

## HELPFUL HINTS

- Only households receiving this notice are eligible for the 2024 Neighborhood Clean-up.
- Items can be set out as early as Sunday, September 8, 2024.
- Items must be out by 7:00am on Monday, September 9, 2024. Crews will move quickly and will not be able to return to an area once they have already been through it.
- Piles should be located on the street, in the gutter, in front of your house.
- Keep piles separate from your household trash containers or other items you do not want removed.
- To avoid property damage, place items at least 3-feet away from buildings, fences, mailboxes, etc.– Crews are not responsible for damage to these structures.
- Do not set debris on private property such as driveways or lawns.
- Do not put out hazardous waste or e-
